New Features:

The Advancement Decision Center provides fund raising activity data extracted from the Advancement system at the close of every business day. The Development and Alumni Relations (DAR) Office are the primary users of the Decision Center. The DAR Technical Services group has developed several dashboards, collectively called the **GWU Campaign Dashboard**, that shows:

- o Total Campaign Donations
- o Donations by Monetary Level
- o Donations by School/Unit
- o Donations by Entity Type
- o Donations by Campaign Use
- o Donations by Campaign Pillar
- o Donations by Transaction Type
- o Donations by Geographic Location

Over 300+ target users for these dashboards include Development Officers, Alumni Relations, Advancement Services and the DAR Executive Team.

That: Provides key information and metrics
Unlike: Compiling data from different sources and merging them together in spreadsheets
This Product: Can be accessed online or on mobile devices, is secure, and pulls data from the data warehouse

New Reports:

- Expect reports to run in a minute or less
- Can be found under Analysis & Reporting > General Ledger Reports

1. GL Income Statement by Org

- o Shows GL activity by Org, aggregated depending on where the selected Org sits in the Org hierarchy
- o Breaks down GL activity by Account Reporting Attributes (eg. Revenues, Expenses, etc.)
- o Shows YTD Actual, YTD Budget, Approved Annual Budget, Prior YTD Actual, Period to Date Actual and variances
- o Allows the user to drill-down to any Account Reporting Attribute to see more detail. Users can drill-down to the GL Line, the GL SLA and A/P Invoices.

Is an: Integrated source of General Ledger data
That: Provides easy to use information that spans multiple years and can be consumed in multiple ways (Reports, Cubes, Dashboards, etc...)
Unlike: The GL-329 Cube
This Product: Will be dimensional at the detail level, automatically updated, secured, and certified

Features:

- GL data from the last 5 fiscal years has been brought into the data warehouse to provide users with the capability to drill down from high-level summary data down to transaction-level data. Data in the warehouse includes:
 - Actuals and Approved Budget from GL Balances
 - Actuals and Approved Budget from GL Headers and Lines
 - Actuals from GL SLA (Sub-ledger Accounting)
 - A/P Invoices

Performance Improvements:

Since the previous release, BIS has been working on improving the performance of the GL Decision Center to speed up queries against more than 30 million rows of GL data.

- Excluded accounts from the General Ledger that have had no activity for the last 5 years
- Created a record set with only the current Fiscal Year's activity for reports that are only concerned with Year-to-Date activity

Unlike: Compiling data from different sources and merging them together in spreadsheets
This Product: Can be accessed online or on mobile devices, is secure, and pulls data from the data warehouse

New Reports:

- **Monthly Run Rate**
 - Summarizes an award's total expenses by month and calculates the average monthly expenditure. The report then projects total expenditures to the end of the award and will predict if the award will go over or under Budget
 - Accessible through the PI Dashboard's More Tools tab: <http://research.gwu.edu/pi-dashboard-visualizations>
- **Labor Effort report**
 - Shows the percent of effort spent by an employee on a given award based on Banner HR Labor Distributions
 - Also includes the percent of effort spent on teaching and on other awards within the same pay period
 - Labor Distributions are broken down by PICT code, pay number, Banner Index and Position No
 - Accessible through the PI Dashboard's More Tools tab: <http://research.gwu.edu/pi-dashboard-visualizations>

Modified Features:

- **Interactive Visualizations**
 - Alerts are now incorporated in the Budget and Actuals visualization. The Alerts tab has been taken out. If an award has an alert, the user will see an exclamation mark "!". Clicking on the award then displays the award's alert/s.
 - An award filter has also been added to let users view only awards with alerts.
 - A new tab has been added called "More Tools". Users will be able to drill to other reports from this tab (see New Reports above).
- Reports include a "Data refreshed on:" date at the bottom right of the dashboard to inform users of when the data was loaded into the warehouse (Note: Barring any technical issues, data on the PI Dashboard is as of the close of the previous business day.)
